Home School Association Agreement 2016-2017

As part of enrolling my/our child(ren) in Northern Chautauqua Catholic School, I/We agree to be a participating member of the Home School Association. - 2.) I/We agree to be responsible for the selling/buying of a certain percentage of raffle tickets based on the enrollment. I/We am/are solely responsible for selling/buying them and returning them in a timely manner. (If you are having trouble selling the tickets, you need to contact a HSA officer for further information. Under no circumstances should tickets be returned unsold. You will be billed for any unsold/unreturned tickets.) The success of this fundraiser relies on these terms and I/We agree to abide by them.
- 3.) I/We agree that my minimum contribution to the Northern Chautauqua Catholic School Home School Association will be \$225 in profit from Home School Association sponsored fundraisers. (Note: There are other fundraisers undertaken within the school that do not count toward your total.) If I/We fall short of my/our fundraising obligation, I/We will be assessed the "Raise My Own Tuition" amount less the profit already raised.
- 4.) I/We understand that my/our minimum contribution **is not sufficient** to cover all of our expenses; therefore I/We agree to participate in additional fundraisers as needed to fulfill the Home School Association's financial burden.
