2025 - 2026 Northern Chautauqua Catholic School Tuition Policy - for students enrolled at NCCS

Tuition Policy Agreement:

- 1. By registering a student, the Parent/ Guardians are agreeing to pay tuition for a full academic year. Tuition may be prorated for mid-year transfers into NCCS. Withdrawal before the beginning or during the academic year will still require the full tuition payment. Therefore, no credit will be given for circumstances beyond the control of the course of an academic year, except for circumstances such as death of a student and/or parent, unanticipated disability of the student and/or parent, a non-voluntary move of more than 25 miles from the original residence or 25 miles from Northern Chautauqua Catholic School, whichever is more. In all cases, the Finance Committee shall determine if any tuition adjustment is necessary and appropriate.
- 2. <u>All Parents/Guardians will be required to enroll in the FACTS Tuition Management System to set up a payment plan for your child/children's tuition</u>. This applies to both new and returning families. FACTS allows you to pay your tuition bill by checking account, savings account or by credit card-(FACTS will charge an additional 3% convenience fee for use of a credit card). Facts also allows you to select your payment date, track your payments, see/print your statements, see the schedule of your payments for the school and produce a report for tax or reimbursement purposes. Payment dates are the 5TH, 10TH, 15TH or 20TH of the month. All payments are due by the 20TH of the month beginning in July, depending on payment option chosen on contract. A late fee of \$30 will be added to your account on the 1ST of the following month for any account which is not current. To use the FACTS Tuition Management System you will need to go to https://online.factsmgt.com/signin/3MBVM to create your new online account or to sign in. This link can also be found on our school's website under the Admissions tab > tuition > bottom of the web page. If you need assistance you may contact FACTS at 1-866-441-4637 or you may see the Finance Manager at NCCS during school hours.
- All Parents/Guardians paying annually are required to make the annual payment by July 20TH. Timely payments will receive a 2% discount. Payments made after the 20TH are not subject to the discount. You will need to enroll in the FACTS Tuition Management System to make this payment and avail yourself of the features highlighted in (2). For tax statements and tracking/billing purposes you will need to create a FACTS account online at the address above.
- The objective of NCCS is to provide a high quality Christian centered educational experience to our students and families. Meeting this objective requires all tuition and after school care payments to be collected in a timely fashion. Any account which is past due negatively affects this objective and will result in the following consequences:
 - a. Student(s) will be barred from participating in any after school activities including but not limited to after school care (a new contract will need to be completed yearly for the after school care program), sports, clubs, social activities, class competitions.
 - b. When accounts become past due after three months, all legal collection options will be pursued including but not limited to collection agencies, credit reporting, wage garnishments, and other legal options deemed necessary by the finance committee.
 - c. Students who are past due will not be allowed to enroll for the next academic year.
 - d. Student's accounts that are past due and receiving tuition assistance/scholarships will forfeit their tuition assistance/scholarship funding. The full tuition costs will be charged to their account and due for the year.
 - e. Collection policies are in accordance with the Federal Fair Debt Collection Practices Act and are applicable to New York State law.

By signing this agreement, you are authorizing NCCS to contact you by phone, cell phone and email.

NCCS promotes all resources available to assist in the reduction of the burden of tuition. The primary source of tuition reduction is the BISON Fund. This fund supersedes any other tuition assistance. Any family who requests tuition assistance from NCCS MUST FIRST APPLY FOR A BISON FUND SCHOLARSHIP ONLINE AT www.bisonfund.com . Additional tuition assistance from NCCS will need to be applied for using the NCCS tuition assistance application which has been included with your enrollment packet. NCCS offers scholarships and specific tuition reduction programs which may vary for each academic year. Enrollment age for Pre-Kindergarten 3 through 8TH Grade is based on the child's age on or before December 1ST of the academic year. Pre-Kindergarten 3 must be 3 by December 1ST and Pre-kindergarten 4 must be 4 by December 1ST.

Please remember the full cost of educating one student at NCCS is approximately \$7,200.00 annually.
